Ian updated the attendees on the recent Reps Training that was held in Kilkenny with the South East Region PPNs and it was hoped that this was a stepping stone to helping PPN Reps have a stronger voice at the table for influencing Policy.

Ian confirmed that details of upcoming training for member groups would be issued shortly. These Workshops are based on the Training needs Analysis carried out during the summer and aimed at addressing the top 5 topics identified by members.

Sergeant David Ferriter gave a very good talk about community policing and support for PPN groups. David highlighted the need to create strong relationships with PPN groups and confirmed that AGS were very happy to help and support in any way they could with events etc.

There was a good discussion on the roles of PPN Representatives, particularly in relation to Strategic Policy Committees. It was felt that members were not aware of the process or responsibilities of the Reps on these committees, and their remit in shaping and influencing policy.
