Which was a statutory right, the core essence for the PPN and encased in law in the Local Government Act 2014.

Kevin Molloy, pointed out that this in turn made Wexford County Council in breach of the memorandum of understanding between themselves and Wexford PPN. He went on to suggest that we should make representation to the Minister for Local Government.

It was decided to write an official letter to the Minister and include the, currently unanswered, letter sent to Tom Enright and Ciara Bates on 6th December 2020.
