HOUSING REPORT:

Amendments of exclusions to the Housing (Sale of Local Authority Houses) Regulations 2015 were presented.

A presentation on housing standards for rented homes covered the regulatory framework introduced by the Residential Tenancies Act 2004 and 2014 outlined the 9 basic elements of inspection for rented property as well as the PRTB 2017 10 point action plan.

The 9 basic elements of inspection cover standards under the headings;

- Structural Conditions,
- Sanitary Facilities
- Heating Facilities
- Food Preparation, Storage & Laundry
- Ventilation
- Lighting
- Fire Safety
- Refuse
- Electricity & Gas

The 10 point action plan covers;

- The necessary training for inspection team
- The targeting of 20%-25% of properties for inspection.
- All HAP properties to be inspected within a timeframe of 8 months.
- To build a directory of contacts for landlords.
- The targeting of inspections in town centres.
- The targeting of inspections of multi unit buildings.
- Enforcement for non compliance.
- Referral to other departments and/or bodies
- Implementation of necessary changes following DOE circulars.
