Welcome & Introductions:

lan Ludlow welcomed everyone and gave an update on the current state of play with Wexford PPN. This included a presentation on the 2023 Workplan, Expenditure, and PPN Representatives. One objective is to move in to 2024, the Reps Round table meeting that was scheduled for Q3. It was felt that the timing would be more suited to Q1 or Q2 in 2024 to coincide with the Local Authority elections.

lan outlined some of the 2023 Highlights which included the National PPN conference and the recent Grant Writing workshop with Yvonne Byrne.

Ian also congratulated Rathgarogue Community Co-operative Society who have been chosen as the Co Wexford project to be put forward for a half a million euro grant application under the Town & Village Renewal scheme.

Sue Kent gave an update on the Community Growers which included a very interesting workshop that was held in Templeshannon Community Centre – Garden Fork to Kitchen Fork. Sue also confirmed that the mailing list was available for attendees to sign up to.

Climate Action Thematic Group:

Patrick Rochford officially launched the Climate Action thematic group, and a good discussion took place around climate action and how the PPN can support community groups on this front. It was hoped that the PPN would host around 8 – 10 climate action events in 2024 for this thematic group.
